#### TAB B: PROPOSED PCSC POLICY AMENDMENTS-FIRST READING

Director Baysinger said that significant changes to statute and administrative rule have resulted in a need for updates to PCSC policies. The proposed changes have been addressed by the PCSC or its committees. She recommended that the PCSC consider the policies at this first reading, then adopt them with any requested changes at a later date, allowing additional time for public comment on the proposed changes.

Chairman Reed asked for input on the timeline for schools' submission of meeting materials.

Commissioners Quinn, Bair, and Peterson expressed support for the existing language allowing submission of additional materials at the chairman's discretion.

Suzanne Budge, lobbyist for K12, stated that they would like to have access to meeting materials and opportunity for public comment as part of the policymaking process. She said that public testimony should be accepted during PCSC meetings.

Director Baysinger clarified that PCSC meeting materials are posted online one week in advance of PCSC meetings, and that written and verbal public comment are accepted up to and during PCSC meetings.

Jane Whittmeyer, lobbyist for the Coalition of Idaho Charter School Families, said the PCSC should investigate how other commissions handle public comment and material.

Teresa Molitor, lobbyist for the Association of Charter School Leaders, expressed that her perception of the commission is that they do not want to hear from public.

Director Baysinger reviewed the proposed policy changes, which would align PCSC policies with Idaho statute, administrative rule, and the new performance framework, as well as reflect updates to the renewal process made in response to stakeholder feedback.

Chairman Reed encouraged the commission and stakeholders to review these policy changes and provide any feedback.

#### TAB C: PCSC 2017 Annual Report

Director Baysinger provided an overview of the 2017 PCSC Annual Report, including academic outcomes, demographics, proficiency rates, growth rates, and graduation rates across the PCSC's portfolio.

The PCSC discussed how best to balance its responsibility to protect the interests of students and taxpayers through upholding quality performance standards with the value of parent choice.
