IDAHO COLLEGE AND CAREER ACADEMY, DBA IDAHO TECHNICAL CAREER ACADEMY FINAL ORDER

On February 10, 2022, the Idaho Public Charter School Commission ("Commission") voted to accept and adopt the consent agreement signed by IDAHO COLLEGE AND CAREER ACADEMY, dba IDAHO TECHNICAL CAREER ACADEMY ("ITCA") and the Director of the Idaho Public Charter School Commission, thereby approving ITCA's renewal application and renewing ITCA's charter for a five-year operational term, to begin July 1, 2022, with the following conditions:

CONDITION 1. At least 27% of ITCA's continuously-enrolled students in grades 9 and 10 achieve proficiency on the statewide math assessment (currently the ISAT) by June 30, 2024. This condition is based on the school making progress toward the proficiency rate necessary to meet standard on this measure.

CONDITION 2. ITCA's negotiated performance certificate shall include a maximum enrollment number not to exceed 800 students. However, ITCA will be permitted to request an increase in this enrollment number through the charter revision process. This condition considers that the average enrollment at ITCA across the 5 years preceding the COVID-19 pandemic was 112 students, and that at the highest point during the pandemic, ITCA's enrollment peaked at 290 students. The purpose of this condition is to ensure budget predictability for all schools and to ensure that emergency growth decisions are made by the appropriate entity. This condition must be met by July 1, 2022.

CONDITION 3. ITCA is no longer "exempt from some or all measures within the financial portion of the Performance Framework," as stated in ITCA's current performance certificate. ITCA's financial outcomes based on the financial measures of the Commission's Performance Framework are no longer exempt from publication in ITCA's annual performance report. The purpose of this condition is to ensure that the public has access to an annual performance report that provides complete and transparent information about ITCA's financial outcomes. This condition must be met by July 1, 2022.

ITCA shall comply with the conditions set forth above.

APPEAL INFORMATION¹

This is a final order of the agency. Any party may file a motion for reconsideration of this final order within 14 days of the service date of this order. The agency will dispose of the petition for reconsideration within 21 days of its receipt, or the petition will be considered denied by operation of law. *See* Idaho Code § 67-5246(4).

Pursuant to Idaho Code sections 67-5270 and 67-5272, any party aggrieved by this final order or orders previously issued in this case may appeal this final order and all previously issued orders in this case to district court by filing a petition in the district court of the county in which:

(a) a hearing was held, (b) the final agency action was taken, (c) the party seeking review of the order resides, or operates its principal place of business in Idaho, or (d) the real property or personal property that was the subject of the agency action is located.

An appeal must be filed within 28 days (a) of the service date of this final order, (b) of an order denying petition for reconsideration, or (c) the failure within 21 days to grant or deny a petition for reconsideration, whichever is later. *See* Idaho Code § 67-5273. The filing of an appeal to district court does not itself stay the effectiveness or enforcement of the order under appeal.

¹ Idaho regulations require this information be provided in all final orders. *See* IDAPA 04.11.01.740.02. However, due to the Consent Agreement signed by both the school and the Director of the Idaho Public Charter School Commission, and the adoption of the Consent Agreement by the Idaho Public Charter School Commission, it is likely not pertinent to this case.
