FINAL ORDER

On February 10, 2022, the Idaho Public Charter School Commission ("Commission") voted to accept and adopt the consent agreement signed by SYRINGA MOUNTAIN SCHOOL, INC., dba SYRINGA MOUNTAIN SCHOOL ("SMS") and the Director of the Idaho Public Charter School Commission, thereby approving SMS's renewal application and renewing SMS's charter for a five-year operational term, to begin July 1, 2022, with the following condition:

CONDITION 1. SMS must successfully complete one of the following:

(1) Achieve a proficiency rate on the spring administration of the statewide literacy assessment (currently the IRI) equal to or greater than the average proficiency rate of the Blaine County School District by June 30, 2023; or

(2) Increase the percent of continuously enrolled students who achieved proficiency on the statewide literacy assessment by at least 10% between the fall and spring administrations of the 2022-2023 school year.

This condition must be met by June 30, 2023. This condition is based on the proficiency rate necessary to meet standard on this measure.

SMS shall comply with the condition set forth above.

IT IS SO ORDERED.

APPEAL INFORMATION¹

This is a final order of the agency. Any party may file a motion for reconsideration of this final order within 14 days of the service date of this order. The agency will dispose of the petition for reconsideration within 21 days of its receipt, or the petition will be considered denied by operation of law. *See Idaho Code § 67-5246(4).*

Pursuant to Idaho Code sections 67-5270 and 67-5272, any party aggrieved by this final order or orders previously issued in this case may appeal this final order and all previously issued orders in this case to district court by filing a petition in the district court of the county in which: (a) a hearing was held, (b) the final agency action was taken, (c) the party seeking review of the order resides, or operates its principal place of business in Idaho, or (d) the real property or personal property that was the subject of the agency action is located.

An appeal must be filed within 28 days (a) of the service date of this final order, (b) of an order denying petition for reconsideration, or (c) the failure within 21 days to grant or deny a petition for reconsideration, whichever is later. *See Idaho Code § 67-5273.* The filing of an appeal to district court does not itself stay the effectiveness or enforcement of the order under appeal.

¹ Idaho regulations require this information be provided in all final orders. *See IDAPA 04.11.01.740.02.* However, due to the Consent Agreement signed by both the school and the Director of the Idaho Public Charter School Commission, and the adoption of the Consent Agreement by the Idaho Public Charter School Commission, it is likely not pertinent to this case.


