Thank you for reviewing and acknowledging that IDVA met the standard for Literacy Proficiency and for removing the Literacy Proficiency condition in the updated notification of recommendation you sent. Thank you, too, for the discussion Monday evening. I appreciate your willingness to listen and the updates you are willing to make to the conditions. I spoke with Chairman Thompson and relayed the proposed updates you and I discussed. I have outlined those below.

- Condition 1 proposal:

    - IDVA's alternative education program, Insight School of Idaho (Insight), must increase its outcome on the Alternative Additional Graduates measure of the Commission's performance framework to 24% by fiscal year 2025.

    - IDVA's alternative education program, Insight School of Idaho (Insight), must increase its outcome on the Alternative Additional Graduates measure of the Commission's performance framework to 22% by fiscal year 2025.
- Condition 2 proposal:
  - · Update this:
    - IDVA's negotiated performance certificate shall include a maximum enrollment number not to exceed 2,700 students.
  - To this:
    - IDVA's negotiated performance certificate shall include a maximum enrollment number not to exceed 5,500 students.

Jeff also appreciates your willingness to listen. Please, make the proposed updates to the notification of recommendation and send us the third version, so we can share it with the rest of the board to get input. The December board meeting will be held December 12<sup>th</sup>, which is not too far in the future. If you could send the updated notification soon, we would, very much, appreciate that.

- Changed IDVA Connections Academy to Idaho Virtual Academy (version 3 of Annual Report)
- Annual Snapshot chart title errors p. 6
  - Changed Inspire Connections Academy and Empower Connections Academy to Idaho Virtual Academy and Insight School of Idaho (version 2 of Annual Report).
- Annual Snapshot Math and ELA Proficiency errors in Insight School of Idaho chart p. 6
  - Changed Math Proficiency from 50% to 19% and ELA Proficiency from 19% to 50% (version 2 of Annual Report)
- Annual Snapshot Insight School of Idaho College & Career Readiness-Additional Graduates error.
  - 33% needs to be changed to 18% (not yet corrected)
- ELA and Math Proficiency errors p. 13
  - Changed Insight's N-Size to <18% in Math Proficiency chart (version 2 of Annual Report)
  - Changed Insight ELA Proficiency to Insight Math Proficiency in Math Proficiency chart (version 3 of Annual Report)
  - Changed Insight's ,18% to <19% in Math Proficiency chart (version 3 of Annual Report)

Annual Report Old Framework errors.

 Operational 2a is exempted and shouldn't be, and 2c is not exempted and should be according to IDVA's current exemptions. (not yet corrected)
