I just received the Sharefile notification and downloaded our final annual report. I haven't had a lot of time to go through it yet, but I did notice a few changes – most of them in the positive direction. I was pleased to see that, although the numbers are the same as they were in the last updated report, Insight's ELA proficiency rating was changed from Meets to Exceeds Standard, too! I also saw the update to the additional graduates measure. The updated report notes that as 21%. As noted below, using the list that was shared with me by Jared, and adding those 2 summer graduates in, the rate would be 23.68%. Did you find additional information when you did the review? Could you, please, send me the list of student level data for our additional graduates calculations?

Hi Jared and Jenn,

I have been reviewing the alternative academic data you shared with me, specifically, the data used for the college and career readiness: additional graduates measure. Two students on the list each have 3E as their exit codes and, therefore, counted negatively for the measure. However, both of these students attended summer school and graduated 7/29/22. Their exit codes were updated to 4A after their graduations. Since the measure says "The percentage of the not continuously enrolled students who were eligible to graduate in the same academic year (plus summer)...." these two students should be counted positively into our metrics. Adding these two graduates gives us 9/38 graduates or 23.68%. I received the data file from you December 27th, which is after the deadline to submit our annual report response form. As we all want the annual reports to reflect correct data, can this be updated on our annual report? Additionally, our renewal recommendation includes a condition for this measure and requires our school to achieve 22%. Since we did actually achieve 23.68%, this seems to be a case for removing this condition.

If you would like the 2 student EDUID numbers, so you can pull a more recent ISEE report to confirm the 4A exit codes for them, please, give me a call at 208-407-8534.
