**OBJECTIONS TO IDVA EXHIBIT
TITLES**

The Idaho Public Charter School Commission Staff objects to the following titles IDVA has given to its exhibits:

1. Exhibit 1

Reason: The official title of the document is “Annual Performance Report 2022”, and it is also referred to as FY22 Annual Report. There is only one final FY22 Annual Report for IDVA, and it was correctly titled and submitted as Commission Staff’s Exhibit H. IDVA’s use of “version 4” in the document title indicates that there were multiple final FY22 Annual Reports, which is inaccurate and potentially misleading. All draft FY22 Annual Reports were preliminary drafts, and such was communicated to IDVA in the emails containing the preliminary drafts. Commission Staff requests that any reference to IDVA’s FY22 Annual Report exclude the phrase “version 4”.

2. Exhibits 2, 3, and 4

Reason: These documents are preliminary drafts exchanged between parties using an iterative approach to make updates or correct mistakes before settling on the final FY22 Annual Report. Referring to these drafts as “incorrect” versions of the final

FY22 Annual Report is inaccurate and potentially misleading. Commission Staff requests that any references to preliminary drafts exclude the word “incorrect.”

3. Exhibit 23

Reason: This exhibit is labeled as “FY22 Quarter 2 Financials...” However, this exhibit appears to be IDVA’s FY20 Quarter 2 and FY21 Quarter 2 reports. Commission Staff requests that any reference to this exhibit include a reference to the correct report.
