26 Be It Enacted by the Legislature of the State of Idaho:

27 SECTION 1. That Section 33-5201, Idaho Code, be, and the same is hereby 28 repealed.

SECTION 2. That Chapter 52, Title 33, Idaho Code, be, and the same is
 hereby amended by the addition thereto of a <u>NEW SECTION</u>, to be known and des ignated as Section 33-5201, Idaho Code, and to read as follows:

32 33-5201. SHORT TITLE. This chapter is known as the "Accelerating Pub-33 lic Charter Schools Act."

34 SECTION 3. That Section 33-5202, Idaho Code, be, and the same is hereby 35 repealed.

SECTION 4. That Chapter 52, Title 33, Idaho Code, be, and the same is
 hereby amended by the addition thereto of a <u>NEW SECTION</u>, to be known and des ignated as Section 33-5202, Idaho Code, and to read as follows:

39 33-5202. LEGISLATIVE INTENT. It is the intent of the legislature to 40 provide opportunities for students, parents, teachers, and community mem-41 bers to attend, establish and maintain public charter schools that operate 42 independently from the existing traditional school district structure but 43 within the existing public school system. Public charter schools are hereby 44 authorized as part of the state's program of public education and they shall DRAFT

have equal access and authority to participate in all state and federal pro-1 grams to the same extent as a traditional public school, irrespective of the 2 3 instructional delivery method. The legislature aims to: (1) Improve student learning; 4 (2) Increase learning opportunities for all students, with special em-5 6 phasis on expanded learning experiences for students; 7 (3) Include the use of different and innovative teaching methods; 8 (4) Utilize virtual and hybrid learning; (5) Create new professional opportunities for teachers, including the 9 opportunity to be responsible for the learning program at the school site; 10 (6) Provide parents and students with expanded choices in the types of 11 12 educational opportunities that are available within the public school sys-13 tem; 14 (7) Hold public charter schools accountable for meeting measurable 15 student educational standards; 16 (8) Reward public charter schools that meet their accountability mea-17 sures with enhanced autonomy and freedom from regulatory burden; and 18 (9) Foster and support charter schools through best practices, devel-19 opment, educational and operational assistance. 20 SECTION 5. That Section 33-5202A, Idaho Code, be, and the same is hereby 21 repealed. 22 SECTION 6. That Chapter 52, Title 33, Idaho Code, be, and the same is 23 hereby amended by the addition thereto of a NEW SECTION, to be known and des-24 ignated as Section 33-5202A, Idaho Code, and to read as follows: 25 33-5202A. DEFINITIONS. As used in this chapter, unless the context re-26 quires otherwise: 27 (1) "Application" means the document submitted to the authorizer to request the creation of a public charter school. 28 29 (2) "Authorizer" means any of the following: 30 (a) A local board of trustees of a school district; (b) The public charter school commission; 31 (c) An Idaho public college, university, or community college; 32 (d) A private, nonprofit, Idaho-based, nonsectarian college or univer-33 sity that is accredited by the same organization that accredits Idaho 34 35 public colleges and universities. (3) "Charter" means the grant of authority approved by the authorizer 36 to the charter holder. 37 (4) "Charter holder" means the public charter school's board of direc-38 39 tors to which a charter is granted. 40 (5)"Educational services provider" means a nonprofit or for-profit entity that contracts with a public charter school for a fee to provide 41 educational services and resources including administrative support and 42 43 educational design, implementation, or management. (6) "Founder" means a person who makes a material contribution toward 44 the establishment of a public charter school and who is designated as such by 45 the charter holder. 46

(7) "Performance certificate" means a fixed-term, renewable certifi cate between a public charter school and an authorizer that outlines the ne gotiated roles, powers, responsibilities and performance expectations for
 each party to the certificate.

(8) "Public charter school" means a school that is authorized under
this chapter to deliver public education in Idaho.

7 (9) "Traditional public school" means any school that is operated and
 8 controlled by a school district in this state.

9 (10) "Virtual school" means a public charter school that delivers 10 a full-time, sequential program of synchronous and/or asynchronous in-11 struction primarily through the use of technology via the internet in a 12 distributed environment. Schools classified as virtual must have an online 13 component to their school with online lessons and tools for student and data 14 management. Students enrolled in a virtual school may meet at the same loca-15 tion and time while receiving virtual instruction.

16 SECTION 7. That Section 33-5203, Idaho Code, be, and the same is hereby 17 repealed.

SECTION 8. That Chapter 52, Title 33, Idaho Code, be, and the same is hereby amended by the addition thereto of a <u>NEW SECTION</u>, to be known and designated as Section 33-5203, Idaho Code, and to read as follows:

21 33-5203. APPROVAL OF PUBLIC CHARTER SCHOOLS. (1) New public charter 22 schools are subject to the following:

(a) No whole school district may be converted to a charter district or
 any configuration that includes all schools as public charter schools;

(b) An application must be received by the authorizer no later than
September 1 to be eligible to begin instruction the first complete
school year following receipt of the application, unless the authorizer
agrees to a later date; and

(c) To begin operations, a newly chartered public school must be autho rized by no later than January 1 of the previous school year, unless the
 authorizer agrees to a later date.

(2) Any authorizer may approve a public charter school formed by creat ing a new public charter school or by replicating an existing public charter
 school. Converting an existing traditional public school to a public char ter school may only be approved by the board of trustees of the school dis trict in which the existing public school is located.

37 (3) No charter shall be approved under this chapter:

(a) That provides for the conversion of any existing private orparochial school to a public charter school;

(b) For a for-profit entity, provided however, nothing in this section
shall prevent the board of directors of a public charter school from
legally contracting with an educational service provider that provides
comprehensive educational administrative and management services or
with for-profit entities for the provision of products or services that
aid in the operation of the school; or

(c) By the board of trustees of a school district if the public charter school's physical location is outside the boundaries of the authorizing school district.

4 (4) A charter holder may not operate enterprises unrelated to the edu5 cational purposes for which the public charter school has been authorized.
6 In cases of related enterprises, no state education funding authorized under
7 this chapter may be used to subsidize the other enterprise.

(5) Each authorized public charter school is hereby designated as a local education agency (LEA) as such term is defined in 34 CFR 300.28, unless
the charter holder and authorizer agree to one of the following alternatives
and notice of such is provided to the state department of education no later
than February 1 of the preceding school year:

(a) Public charter schools authorized by the board of trustees of aschool district may be included in that district's LEA; or if

15 (b) Entities with multiple charters may operate as a single LEA.

SECTION 9. That Section 33-5204, Idaho Code, be, and the same is hereby repealed.

SECTION 10. That Chapter 52, Title 33, Idaho Code, be, and the same is hereby amended by the addition thereto of a <u>NEW SECTION</u>, to be known and designated as Section 33-5204, Idaho Code, and to read as follows:

33-5204. NONPROFIT CORPORATION - LIABILITY - INSURANCE. (1) A public
 charter school shall be organized and managed under the Idaho nonprofit cor poration act. The board of directors of a public charter school shall be
 deemed public agents authorized to operate and control the public charter
 school.

26 (2) For the purposes of section 59-1302(15), Idaho Code, a public char-27 ter school created pursuant to this chapter is deemed a governmental entity. Pursuant to the provisions of section 63-36220, Idaho Code, sales to or pur-28 chases by a public charter school are exempt from payment of the sales and 29 30 use tax. Pursuant to section 63-602A(1), Idaho Code, property belonging to 31 a public charter school is exempt from taxation. Every employee and board of director of the charter holder are subject to the provisions of and shall 32 comply with: 33

(a) Sections 18-1351 through 18-1362, Idaho Code, on bribery and cor rupt influence, except as provided by section 33-5204A(2), Idaho Code;
 (b) Chapter 5, title 74, Idaho Code, on prohibitions against contracts

(b) Chapter 5, title 74, Idaho Code, on prohibitions against contracts
 with officers;

38 (c) Chapter 4, title 74, Idaho Code, on ethics in government;

39 (d) Chapter 2, title 74, Idaho Code, on open public meetings;

- 40 (e) Chapter 1, title 74, Idaho Code, on disclosure of public records;41 and
- (f) Professional codes and standards approved by the state board of education, including standards for ethics or conduct. In the event any
 code or standard approved pursuant to this paragraph conflicts with any
 other section of Idaho Code, then Idaho Code shall govern.

46 (3) A public charter school may sue or be sued, purchase, receive, hold47 and convey real and personal property for school purposes, and borrow money

for such purposes, to the same extent and on the same conditions as a tra-1 2 ditional public school district, and its employees, directors and officers shall enjoy the same immunities as employees, directors and officers of tra-3 ditional public school districts and other public schools, including those 4 5 provided by chapter 9, title 6, Idaho Code. The authorizer that approves a public school charter has no liability for the acts, omissions, debts or 6 other obligations of a public charter school, except as may be provided in 7 the charter. A local public school district has no liability for the acts, 8 omissions, debts or other obligations of a public charter school located in 9 its district that has been approved by an authorizer other than the board of 10 11 trustees of the local school district.

(4) Nothing in this chapter prevents the charter holder from borrowing money to finance the purchase or lease of school building facilities, equipment and furnishings. Subject to the terms of a contractual agreement between the board and a lender, nothing herein shall prevent the charter holder from using the facility, its equipment and furnishings as collateral for the loan.

18 (5) Public charter schools shall secure insurance for liability and 19 property loss.

(6) The receiving, soliciting or acceptance of moneys of a public char-20 21 ter school for deposit in any bank or trust company, or the lending of mon-22 eys by any bank or trust company to any public charter school, shall not be 23 deemed to be a contract or other transaction pertaining to the maintenance or conduct of a public charter school and authorizer within the meaning of 24 this section; nor shall the payment by any public charter school board of di-25 26 rectors of compensation to any bank or trust company for services rendered 27 in the transaction of any banking business with such public charter school 28 board of directors be deemed the payment of any reward or compensation to any 29 officer or director of any such bank or trust company within the meaning of this section. 30

(7) Each charter holder shall adopt a policy regarding the hiring of

A charter holder shall strive to ensure that citizens in the primary attendance area are made aware of the enrollment opportuni-8 ties and deadline. The public notice must include the enrollment deadline, 9 10 the public charter school's total enrollment capacity for the next school year, and an advisory that all prospective students will be given the oppor-11 tunity to enroll in the public charter school, regardless of race, color, 12 national origin, ethnicity, religion, gender, socioeconomic status, or 13 special needs. 14

The 42 sibling preference in subsequent school years applies to siblings of a 43 returning pupil and of a pupil selected by the lottery or other random 44 method. Provided however, any public charter school that is formed by the con-42 version of an existing traditional public school shall be assigned divisors, 43 44 pursuant to section 33-1002, Idaho Code, that are no lower than the divisors 45 of the school district in which the traditional public school is located, for 46 each category of pupils listed.

(3) Special education. For each student enrolled in the public charter
school who is entitled to special education services, the state and federal
funds from the exceptional child education program for that student that
would have been apportioned for that student to the school district in which
the public charter school is located.

6 (4) Alternative school support. Public charter schools may qualify 7 under the provisions of sections 33-1002 and 33-1002C, Idaho Code, provided 8 the public charter school meets the necessary statutory requirements and 9 students qualify for attendance at an alternative school as provided by rule 10 of the state board of education.

(5) Transportation support. Support shall be paid to the public char-11 ter school as provided in chapter 15, title 33, Idaho Code, and section 12 33-1006, Idaho Code. Each public charter school shall furnish the depart-13 ment with an enrollment count as of the first Friday in November of public 14 charter school students who are eligible for reimbursement of transporta-15 tion costs under the provisions of this subsection and who reside more than 16 one and one-half (1 1/2) miles from the school. The state department of edu-17 cation is authorized to include in the annual appropriation to the charter 18 school sixty percent (60%) of the estimated transportation cost. The final 19 appropriation payment in July shall reflect reimbursements of actual costs 20 pursuant to section 33-1006, Idaho Code. To be eligible for state reimburse-21 ment under the provisions of section 33-1006, Idaho Code, the student to be 22 transported must reside within the public charter school's primary atten-23 dance area and must meet at least one (1) of the following two (2) criteria: 24

(a) The student resides within the school district in which the public
 charter school is physically located; or

(b) The student resides within fifteen (15) miles of the public charter
school, by road. The limitations placed by this subsection on the reimbursement of transportation costs for certain students shall not apply
to public virtual schools.

31 (6) Facilities funds.

The state department of education shall distribute facilities 32 (a) funds to public charter schools for each enrolled student in which a 33 majority of the student's instruction is received at a facility that is 34 owned or leased by the public charter school. Such funds shall be used 35 to defray the costs associated with payments for real property used by 36 the students or employees of the public charter school for educational 37 or administrative purposes. Such funds shall be distributed from the 38 moneys appropriated to the educational support program and shall be 39 calculated as fifty percent (50%) of the statewide average amount of 40 bond and plant facility funds levied per student by Idaho school dis-41 42 tricts.

For those public charter schools that do not receive facilities 43 (b) funds for all enrolled students, the school may submit to the state 44 department of education a reimbursement claim for any costs for which 45 facilities funds may be used. The state department of education shall 46 reduce such claim by the greater of fifty percent (50%) or the percent-47 age of the school's enrolled students for which the school receives 48 facilities funds and shall pay the balance. Provided however, that the 49 total reimbursements paid to a public charter school, in combination 50

with any facilities stipend received by the school, shall not exceed the amount of facilities funds that would have been received by the school had the school received facilities funds for all enrolled students. For the purposes of this subsection, the term "real property" shall be used as defined in section 63-201, Idaho Code.

(7) Payment schedule. The state department of education is authorized 6 to make an advance payment of twenty-five percent (25%) of a public charter 7 school's estimated annual apportionment for its first year of operation, 8 9 and each year thereafter, provided the public charter school is serving more 10 grades or at least ten percent (10%) more classes than the previous year, to assist the school with initial start-up costs or payroll obligations. For a 11 public charter school entering its second or greater year of operations, the 12 state department of education may require documentation establishing the 13 14 need for such an advance payment, including comparative class schedules and 15 proof of a commensurate increase in the number of employees.

(a) For a public charter school to receive the advance payment, the
school shall submit its anticipated fall membership for each grade
level to the state department of education by June 1.

(b) Using the figures provided by the public charter school, the state
department of education shall determine an estimated annual apportionment from which the amount of the advance payment shall be calculated.
Advance payment shall be made to the school on or after July 1 but no
later than July 31.

(c) All subsequent payments, taking into account the onetime advance 24 payment made for the first year of operation, shall be made to the public 25 charter school in the same manner as other traditional public schools in 26 27 accordance with the provisions of section 33-1009, Idaho Code. A public charter school shall comply with all applicable fiscal requirements of 28 law, except that the following provisions shall not be applicable to 29 public charter schools: that portion of section 33-1004, Idaho Code, 30 relating to reduction of the administrative and instructional staff 31 allowance and the pupil service staff allowance when there is a dis-32 crepancy between the number allowed and the number actually employed; 33 and section 33-1004E, Idaho Code, for calculation of district staff 34 35 indices.

(8) If an authorizer has reason to believe that a public charter school 36 cannot remain fiscally sound for the remainder of its certificate term, it 37 38 shall provide the state department of education with written notification of such concern. Upon receiving such notification, the state department of ed-39 40 ucation shall have the authority to modify the percentage of the total appropriation to be paid to the public charter school pursuant to the provisions 41 of section 33-1009(1), Idaho Code, such that equal percentages are paid on 42 each of the prescribed dates. 43

(9) Each public charter school shall pay an authorizer fee to its authorizer not to initially exceed twenty thousand dollars (\$20,000) or up to a
five percent (5%) increase of the previous year's fee in the case of existing
charter schools. Authorizers shall annually set the authorizer's fee and in
doing so shall document the fees to actual expenditures associated with authorizing.

IV. RENEWAL CONDITIONS - iSucceed Virtual High School

BACKGROUND

In 2022, iSVHS was conditionally renewed with a 5-year operating contract. Conditions were established with the school with deadlines. Should the school meet all conditions by the established deadlines, it may continue operating until its next renewal cycle. However, failure to meet any condition by the established deadline requires that the authorizer, at its next public meeting, consider whether mid-term revocation of the school's charter is warranted.

The following condition has been determined to be "Unmet":

Due 10/31/23:

CONDITION UNMET:

iSucceed's alternative program will meet standard on the IPCSC's Progress Toward Graduation measure at the end of the 2022-23 school year. This condition will be evaluated by October 31, 2023. The evaluation will be consistent with the formula for this measure as it is defined in the Commission's Performance Framework incorporated into iSucceed's active Performance Certificate as of October 31, 2023. The measures will be based on instructional days rather than calendar days.

Please reference the FY23 Annual Performance Report attached.

DISCUSSION

Pursuant to Idaho Code section 33-5209C (7), if a school's charter is renewed with conditions and the school subsequently fails to meet any one of those conditions by the specified dates, the school's charter may be revoked by the Commission.

The IPCSC may consider whether to begin revocation proceedings at the next regularly scheduled meeting.

Introduction

COMPLIANCE/AUTHORITY:

Charter schools in Idaho operate on 5-year terms as defined in a Performance Certificate executed between the school's board and its authorizer. In addition, <u>I.C. §33-5209A</u> and <u>I.C. §33-5209C</u> require that every certificate include a framework describing the expectations the school must meet in order to earn a next operational term. RENEWAL CONDITIONS

In 2022, iSVHS was conditionally renewed with a 5-year operating contract. Each of the following (3) conditions must be met by the deadline established below. Should the school meet all conditions by the established deadlines, it may continue operating until its next renewal cycle. However, failure to meet any condition by the established deadline requires that the authorizer, at its next public meeting, consider whether mid-term revocation of the school's charter is warranted. Below are the conditions that iSVHS has been authorized to operate under:

• <u>Condition 1</u>:

Due 10/31/23: CONDITION UNMET: ISUCCEED's alternative program will meet standard on the IPCSC's Progress Toward Graduation measure at the end of the 2022-23 school year. This condition will be evaluated by October 31, 2023. The evaluation will be consistent with the formula for this measure as it is defined in the Commission's Performance Framework incorporated into ISUCCEED's active Performance Certificate as of October 31, 2023. The measures will be based on instructional days rather than calendar days.

<u>Condition 2</u>:

Due 6/30/24: The percentage of continuously enrolled students in grades 10-12 who are enrolled in ISUCCEED's alternative program, referred to as iSucceed Academy, and who successfully complete 2 credits of math must be 5% greater by June 30, 2023 than the school's 2021 rate, <u>and must either meet standard as it is defined in the Commission's Performance Framework or be 10% greater than the school's 2021 rate by June 30, 2024.</u>

• <u>Condition 3</u>: CONDITION MET

ISUCCEED's negotiated performance certificate shall include a maximum enrollment number not to exceed 1,800 students across grades 7-12. However, ISUCCEED will be permitted to request an increase in this enrollment number through the charter revision process. This condition considers that the average enrollment at ISUCCEED across the 5 years preceding the COVID-19 pandemic was 514 students, and that at the highest point during the pandemic, ISUCCEED's enrollment peaked at 1,009. This condition also considers that ISUCCEED was approved to add 7th and 8th grade in a 2020 performance certificate amendment. The purpose of this condition is to ensure budget predictability for all schools and to ensure that emergency growth decisions are made by the appropriate entity. This condition must be met by June 30, 2022.

Students enrolled at alternative schools face additional barriers to academic success. Often, these students are behind in grade-level proficiency in both Math and ELA. This means that the traditional academic measures may not accurately reflect whether a school that exclusively serves at-risk students is successfully serving the needs of its student population.

The content mastery measure considers the percentage of students who were continuously enrolled at the school for the whole year who earned credit for the equivalent of one school year in Math and ELA, regardless of the grade-level of the course taken. This measure acknowledges that a student enrolled in 8th grade, may not perform well on the 8th grade ISAT assessment if his or her skills are at the 6th grade level; however, if that student mastered the content (earned full credit) in the next course in his/her own academic progression, that success should be noted for the student and the school.

Why this Matters:

This measure estimates a school's average daily cost of operations and considers the number of days a school could operate using only its available cash and investments.

A school with at least 60 days cash on hand would be able to meet its immediate financial obligations with available cash, buying the time it might



take to access other current assets. Occasionally, a planned purchase may decrease this number temporarily. In those cases, 30-60 days cash on hand with an upward trend is acceptable. A school with less than 15 days cash on hand is in financial distress and is at risk of automatic closure.

<u>Default</u>

Any act of default can result in disruption of services, loans being called due, or funding that is inaccurate or withheld.

Why this Matters:

The Enrollment Variance measure considers what percentage of a school's projected enrollment was achieved. As the majority of a public school's funding is generated by student enrollment, this measure reflects a school's ability to execute its budget to plan.

A school that achieves at least 95% of its projected enrollment will likely experience few bumps

and may make minor adjustments. A school that achieves less than 95% of projected enrollment is likely to face budget challenges requiring more significant budget amendments and may be in financial distress.

Why this Matters:

The Total Margin compares a school's total revenue to its net income. Specifically, this measure identifies what percentage of a school's total revenue in a given year was not expended during that year. A school with a positive total margin spent less than it brought in. That is, the school is living within its means and can plan for future purchases and investments.

An occasional negative total margin may indicate that a planned or necessary purchase has taken place. This is not necessarily a negative indicator. However, if the Total Margin is chronically negative or severe decreases appear, the school may be in financial distress. BACKGROUND

North Star Charter School is requesting an amendment to their 2023 – 2028 Performance Certificate to remove a key design element. This change is considered a "major amendment" and as such, requires IPCSC approval.

The specific request to amend the current Performance Certificate of North Star Charter School is to remove Section 2(c) pertaining to the school's key design element of offering an International Baccalaureate Diploma Program.

IMPACT

CHARTER SCHOOL PERFORMANCE CERTIFICATE

This Performance Certificate ("Certificate") is executed on June 8, 2023, by and between the Idaho Public Charter School Commission (the "Authorizer") and North Star Charter School, Inc. (the "Charter Holder") for the purpose of operating North Star Charter School (the "School"), an independent public school organized as an Idaho nonprofit corporation and established under the Public Charter Schools Act of 1998, Idaho Code section 33-5201 *et seq.*, as amended (the "Charter Schools Act").

RECITALS

WHEREAS, North Star Charter School, Inc. is a non-profit entity incorporated with a board of directors; and

WHEREAS, on April 22, 2002, Joint School District No. 2, the Authorizer approved a charter petition for the establishment of the School; and

WHEREAS, the School began operations in the year 2003; and

WHEREAS, the Charter Schools Law was amended effective as of July 1, 2013 to require all public charter schools approved prior to July 1, 2013 to execute performance certificates with their authorizers no later than July 1, 2014;

WHEREAS, on October 9, 2014, the Authorizer, Joint School District No. 2, and the School agreed to a transfer of the School's performance certificate and charter to the Authorizer;

WHEREAS, the School's charter was renewed on March 1, 2018, for a five-year term of operations,

WHEREAS, on February 23, 2023, the Authorizer renewed the School's charter for a subsequent five-year term of operations to begin July 1, 2023 and end on June 30, 2028.

NOW THEREFORE in consideration of the foregoing recitals and the mutual understandings contained herein, the Authorizer and North Star Charter School, Inc. agree as follows:

SECTION 1: TERMS OF AUTHORIZATION

- A. Establishment of School. The Charter Holder is hereby authorized to implement at the School the program described in the Charter, attached to this Certificate as Appendix C and incorporated herein by this reference. Any significant changes to any section of the Charter, including the educational program, facilities plan, financial plan, or the management plan, during the School's pre-operational period or first operational term shall be treated as an amendment in accordance with the Authorizer's policy.
- **B.** Term of Agreement. The School's operational term shall be from July 1, 2023 and end on June 30, 2028. Subsequent terms of operation may be issued by the Authorizer in accordance with

Idaho Code and Authorizer policy.

SECTION 2: EDUCATIONAL PROGRAM

- A. School Mission. The mission of the School is as follows: North Star Charter School provides students a world-class education characterized by a safe, supportive and structured learning climate that encourages high academic achievement, intellectual confidence, leadership and virtuous citizenship.
- B. Grades Served. The School may serve students in grades Kindergarten through 12.
- **C. Design Elements.** The School shall implement and maintain the following essential design elements of its educational program:
 - The School will provide each student a rigorous world-class educational program, encouraging collaborative learning, academic achievement, intellectual confidence and virtuous leadership. This can be measured via observation and lesson plans.
 - Through the Character Leadership Program, the School will strive to remove fear, threat and intimidation from the classroom, creating the environment in which learning can best take place. This can be measured via observation and policy review.
 - The School will advocate for all students' social, emotional, and physical wellbeing. This can be measured via observation.
 - A Business/Economics emphasis will be woven throughout the curriculum to teach the influences of business and economic decisions in our lives, communities and world. This can be measured via observation and curriculum.
 - The School will implement the International Baccalaureate (IB) Diploma Program for grades 11-12, providing students with a curriculum that is intellectually challenging and utilizes rigorous assessments to prepare students for the demands of college and employment. This can be measured via observation, data analysis and policy review.
 - In addition to core subject matter, the school will support the development of the whole child by providing opportunities in music, art, inventiveness, and cultural awareness. This can be measured via observation and curriculum.
- **D.** Standardized Testing. Students of the School shall be tested with the same standardized tests as other Idaho public school students.
- **E.** Accreditation. The School shall be accredited as provided by rule of the State Board of Education. The School shall be accredited or appropriately credentialed by Cognia. All reports issued to the School from the accrediting agency shall be submitted to the Authorizer within five days of receipt.

SECTION 3: SCHOOL GOVERNANCE

A. Governing Board. The School shall be governed by a non-profit board of directors (the "Board") incorporated by the Charter Holder. The Board shall serve as public agents authorized by the Authorizer, in a manner that is consistent with the terms of this Certificate, so long as such provisions are in accordance with state and federal laws, rules and regulations. The Board shall have final authority with respect to the School's operation, and shall have the responsibility of

overseeing academic achievement, financial stability, and operational management of the School. The Charter Holder shall also be responsible for maintaining and enforcing a compliant Board and providing overall Board stewardship for the School.

- **B.** Articles of Incorporation and Bylaws. The articles of incorporation and bylaws of the Charter Holder shall provide for governance of the operation of the School as a nonprofit corporation and a public charter school, and shall at all times be consistent with all applicable laws, rules, regulations, and this Certificate. The Charter Holder shall notify the Authorizer of any modification to the articles of incorporation or bylaws within five business days of approval by the Charter Holder.
- **C.** Charter Board Composition. The composition of the Board shall at all times be determined by and consistent with the articles of incorporation and bylaws, and all applicable laws, rules, regulations, and policies. The Charter Holder shall notify the Authorizer of any changes to its composition and provide an amended School Leadership Roster within five business days of it taking effect.

SECTION 4: AUTHORIZER ROLE AND RESPONSIBILITIES

- A. Oversight Allowing Autonomy. The Authorizer's role shall be to evaluate the School's performance outcomes according to this Certificate and the Performance Framework, and shall be to provide compliance oversight. The Authorizer shall comply with the provisions of the Charter Schools Act and the terms of this Certificate in a manner that does not unduly inhibit the autonomy of the School.
- **B.** Charter School Performance Framework. The Charter School Performance Framework ("Performance Framework") is attached and incorporated into this agreement as Appendix A. The Performance Framework shall be used to annually evaluate the School's academic achievement, Board stewardship, operational management, and financial stability. The specific terms of the Performance Framework are determined by the Authorizer and shall be binding on the School.
- **C.** Separate Academic Evaluations. The academic performance outcomes of the K-12 on-site program operated by the School shall be aggregated across all grades for reportability.
- **D. Identified Comparison Group.** For purposes of evaluating the School against the metrics and measures established in the Performance Framework, the School's comparison group shall be identified as described below and shall be established for the length of the Certificate term. Joint School District No. 2 (002).
- E. Authorizer to Monitor School Performance. The Authorizer shall monitor and report on the School's progress in relation to the indicators, measures, metrics, and targets set out in the Performance Framework. A formal report of the School's academic, financial, and operational performance ("Performance Report") shall be provided to the school and the public by the Authorizer annually. Data necessary to conduct this evaluation will be collected throughout the year. Additional reviews may be necessary if compliance concerns arise.
- **F.** School Performance. The School shall meet standard on all measures of the Performance Framework. The Authorizer shall renew any charter in which the School met all the terms of its Certificate, including all appendices, at the time of renewal.

- **G.** Performance Framework as Basis for Renewal of Charter. The School's performance in relation to the Performance Framework shall provide the basis upon which the Authorizer shall decide whether to renew the School's Charter at the end of the Certificate term.
- **H. Required Reports.** The School shall prepare and submit reports as required by the Authorizer's policy.
- I. Authorizer's Right to Review. The Authorizer maintains the right to request and review additional documentation if such becomes necessary in the course of regular oversight duties or to investigate the validity of a compliance concern. The Authorizer shall conduct its reviews in a manner that does not unduly inhibit the autonomy granted to the School.
- J. Site Visits. The Authorizer may conduct site visits in accordance with the Authorizer's policy. Reports from any site visit shall be made available to the School and shall be included in the School's annual Performance Report.

SECTION 5: SCHOOL OPERATIONS

- **A.** In General. The School and the Charter Holder shall operate at all times in accordance with all federal and state laws, rules, regulations, local ordinances, and Authorizer policies applicable to public charter schools.
- **B.** Maximum Enrollment. The maximum number of students who may be enrolled in the school shall be 1020 students.
- **C. Equitable Enrollment Procedures.** The School shall make student recruitment, admissions, enrollment, and retention decisions in a nondiscriminatory manner and without regard to race, color, creed, national origin, sex, marital status, religion, ancestry, disability or need for special education services. In no event may the School limit admission based on race, ethnicity, national origin, disability, gender, income level, athletic ability, or proficiency in the English language. If there are more applications to enroll in the School than there are spaces available, the School shall select students to attend using a random selection process that shall be publicly noticed and open to the public.
 - i. **Calendar.** The School shall operate on a traditional nine-month calendar in which the last day of the regular term shall fall on or before June 30
 - ii. The School will not offer a summer school session for the purpose of acceleration and/or credit recovery.
- D. School Facilities. The School shall operate at the following location(s): 839 N Linder Road, Eagle, Idaho, 83616. The School shall provide the Authorizer with facilities documentation, including occupancy permits, fire marshal reports, building inspection reports, and health department reports for any facility newly occupied by the School, and any remodeling or construction project for which such documentation is necessary in accordance with Authorizer policy and in accordance with law, rule, regulations, and authorizer policy.
- E. Attendance Area. The School's primary attendance area shall be used for the purposes of determining applicability of this enrollment preference category. The School's primary attendance area is as follows: East of Can-Ada Rd, South of Beacon Light to include Lanktree Gulch to High Country to Deep Canyon, West of Highway 55 to Eagle Rd, North of Cherry Lane.

- **F. Staff.** Instructional staff shall be certified as provided by rule of the State Board of Education. All full-time staff members of the School shall be covered by the Public Employee Retirement System of Idaho, federal social security, unemployment insurance, worker's compensation insurance, and health insurance.
- **G.** Alignment with All Applicable Law. The School shall comply with all applicable federal and state laws, rules, and regulations. In the event any such laws, rules, or regulations are amended, the School shall be bound by any such amendment upon the effective date of said amendment.

SECTION 6: SCHOOL FINANCE

- **A. General.** The School shall comply with all applicable financial and budget laws, rules, regulations, and financial reporting requirements, as well as the requirements contained in the School's Performance Framework.
- **B.** Financial Controls. At all times, the Charter Holder shall ensure that the School maintains appropriate governance, managerial procedures, and financial controls, which shall include, but not be limited to: (1) commonly accepted accounting practices and the capacity to implement them; (2) a checking account; (3) adequate payroll procedures; (4) procedures for the creation and review of monthly and quarterly financial reports, which procedures shall specifically identify the individual who will be responsible for preparing such financial reports in the following fiscal year; (5) internal control procedures for cash receipts, cash disbursements and purchases; and (6) maintenance of asset registers and financial procedures for grants, all in accordance with state and federal laws, rules, regulations, and Authorizer policy.
- **C.** Financial Audit. The School shall submit audited financial statements from an independent auditor to the Authorizer no later than November 1 of each year.
- **D. Annual Budgets.** The School shall adopt a budget for each fiscal year, prior to the beginning of the fiscal year. The budget shall be in the Idaho Financial Accounting Reporting Management Systems (IFARMS) format or any other format as may be reasonably requested by the Authorizer.

SECTION 7: TERMINATION, NON-RENEWAL AND REVOCATION

- **A. Relinquishment.** Should the Charter Holder choose to relinquish its Charter before the expiration of this Certificate, it may do so upon written notice to the Authorizer. In such a case, the Authorizer's closure protocol shall begin immediately following written notification.
- **B.** Nonrenewal. The Authorizer may non-renew the Charter at the expiration of the Certificate if the School failed to meet one or more of the terms of its Certificate, including the Performance Framework. The Charter Holder may appeal a decision to non-renew directly to the State Board of Education.
- **C. Revocation.** The School's Charter may be revoked as provided by Idaho Code section 33-5209C. In such an event, the Authorizer shall consider whether to revoke the School's Charter at its next regularly scheduled meeting. The decision shall be made at that time. The Charter Holder may appeal a decision to revoke directly to the State Board of Education.
- **D.** Closure. The Authorizer's closure protocol shall begin immediately after a decision to relinquish is made by the Charter Holder, or a decision to revoke or non-renew or is made by the Authorizer.

Closure protocol shall begin regardless of whether the Charter Holder appeals the decision. In the event that closure protocol begins, the School shall cease operations no later than the following June 30. Closure protocol shall only cease if the State Board of Education overturns the Authorizer's decision.

SECTION 8: MISCELLANEOUS

- **A.** No Employee or Agency Relationship. None of the provisions of this Certificate will be construed to create a relationship of agency, representation, joint venture, partnership, ownership, or employment between the Authorizer and the School.
- **B.** Additional Services. Except as may be expressly provided in this Certificate, as set forth in any subsequent written agreement between the School and the Authorizer, or as may be required by law, neither the School nor the Authorizer shall be entitled to the use of or access to the services, supplies, or facilities of the other.
- **C.** No Third-Party Beneficiary. This Certificate shall not create any rights in any third parties, nor shall any third party be entitled to enforce any rights or obligations that may be possessed by either party to this Certificate.
- **D.** Amendment. This Certificate may be amended by agreement between the School and the Authorizer in accordance with Authorizer policy. All amendments must be in writing and signed by the School and the Authorizer.

IN WITNESS WHEREOF, the Authorizer and the Charter Holder have executed this Performance Certificate to be effective June 8, 2023.

Petition Review Summary

North Idaho Classical Academy is a proposed American classical education school located outside Bonners Ferry, Idaho. The curriculum is well-designed, and blends American values and traditional classical education elements (e.g., Latin, studying literary classics, etc.). The school plans on enrolling 210 students in grades K-6 in the first year of operations, and expand to 381 students in grades K-12 in year seven of operations. This proposed school is a replication of the Treasure Valley Classical Academy (TVCA) located in Fruitland, ID, currently in its fourth year of operations and up for renewal in 2024. TVCA is in good standing on all IPCSC framework measures.

The school's administrator is currently serving as a BLUUM fellow, providing an opportunity to have a solid, stable leader in place prior to the proposed opening date of 2025. Board directors appear to have varied backgrounds, and receive support from several advisors, including Hillsdale College.

The school expects to receive grants from JKAF (administered and approved via Bluum) in order to complete school funding and start-up costs. Documentation of financial agreements are not included in the final petition.

The petition does not currently meet the following Standards of Quality as detailed herein, and revisions should prioritize these: Section II.1.B; II.1.C; II.4.C

Summary of Section Ratings





Section I: Educational Program:

Standard Rating: Meets Standard

Comments

The petition proposes an American classical education model. The school is a Hillsdale K-12 Candidate Member School, which allows the school to use the Hillsdale curriculum free of cost through the partnership. The school will recruit teachers via a national recruitment network.

The curriculum emphasizes virtuous living, traditional learning, and civic responsibility. The curriculum is informed by the Core Knowledge Sequence, Singapore Mathematics, and the Well-Ordered language curriculum, among others. Students will also learn Latin in grades six through nine, and advanced Latin in grades ten through twelve.

Strengths:

• The curriculum is established and supported by the developing institution.

Concerns:

• No concerns with this section.

Section II: Financial and Facilities Plan Standard Rating: Approaches Standard

Comments

The petition proposes making updates to an existing facility, with a tentative purchase and sale agreement in place. The school has secured several letters of interest from funding sources, and an agreement with BLUUM to provide back-office services during the initial years of the service agreement.

Strengths:

- A services agreement from BLUUM is included in the petition. The school has a plan for these services to phase out over the course of the initial performance certificate.
- The school has received donations from four unnamed donors totaling \$1.24 million dollars (page 104).

Concerns:

- Financial documents and letters of interest are not executed. Understanding that the school needs to have their charter authorized prior to executing financial documents, the school may be requested to provide executed service and purchase agreements and relative financing and charitable agreements to the Commission before the charter's authorized start date.
- The petition presents two facility options; however, they are for the same facility site, with the second option providing a more scaled-down option by reducing the use and construction of the existing school buildings. This maybe a particular risk as the proposed contract contains language that provides an "out-clause" (page 151) which may require a separate site if terms cannot be met.

Section III: Board Capacity and Governance Structure

Standard Rating: Meets Standard

Comments

The board is comprised of five members, including a software company owner/executive at Kapex Technology, CEO of BLUUM, a former registered nurse (St. Luke's), a retired bank executive and home renovation owner/operator at The Saylor Corp., and an Information Technology auditor at Stratagroup.

The board is part of a network, American Classical Schools of Idaho (ACSI). ACSI manages two schools in the IPCSC portfolio, Treasure Valley Classical Academy (TVCA) and Idaho Novus Classical Academy (INCA).

The board also has two advisors: Major General Mark Dillon, with military and education consulting background, and Dr. Jon Fennell, chairman of the Education Department at Hillsdale College.

Strengths:

- The board currently oversees two charter schools in the IPCSC portfolio (Treasure Valley Classical Academy, Idaho Novus Classical Academy).
- The board has a plethora of experience and members possess a wide range of skills that aid in executing their responsibilities.

Personal introductions – Please take a moment to introduce yourself and share a little about the role you've played in the petition process so far.

1. How do you define what a successful charter school looks like?

Finding an excellent school leader is important. The location and layout of an area is important as well. The curriculum is also important, and increased experience provides opportunities for financing that hadn't been seen in the past. This also helps, as teachers are coming to them looking for positions.

2. What are some of your biggest lessons learned and changes made since your first school began operations? What challenges remain to be addressed?

Have facilities identified up front, in order to ensure that all planned spaces are available and able to acquire. Two board members visited the facility a couple of weeks ago, the current owner of the facility is very supportive, and kind of a partner. The board has developed very supportive partners in this process.

3. What are your plans for recruiting students? What are your thoughts on recruiting for a school in what might be considered a smaller market area?

Staff do source from other schools, and there is strong recruiting and strong interest. Apartments built on an adjacent property owned by the seller are available for teachers moving to the area to help with housing. Relationship with seller is "kind of" a partnership, nothing written/executed for housing help, etc. Teachers interested so far mostly seem to have experience with the classical model.

4. What has been or what will be the board's involvement in negotiating contracts, like purchasing the property, construction of the buildings, curriculum purchase, service providers?

ACSI leadership (e.g., Executive Director Lambert) takes the lead on negotiations and major contracts. He is inclusive on contracts, hands them off with a recommendation, board talks through and approves contracts. Chair Lasnick is more involved up front in communication with Executive Director, as progresses will branch out to more than Chair. Legal counsel is also involved in reviewing contract language, identifying risk, etc.

5. How will you involve the community and also be available for the community to participate in board meetings? Will you have board meetings at the school campus during the year?

There is potential for travel; the model is to have someone local to the community for network schools, and have someone from local community on board to represent. Parent/teacher committees with a board liaison are also ways to maintain availability. The Executive Director has property in the community, and will be involved in the community in that way as well.

Follow-up question related to facility safety, as facility is spread out, etc. TVCA is the model.

Follow-up question related to board member on-boarding. The Governance Committee is working on a packet for board members. Hillsdale provides board training that new board members are required to attend.

Section IV: Student Demand and Primary Attendance Area

Standard Rating: Meets Standard

Comments

The school intends to open in the Fall of 2025, initially serving grades K-6, adding one grade level each year to expand to grades K-12 by year seven of operations (the school will serve grades K-10 in the final year of the initial performance certificate). The school will enroll 210 students in year one, reaching a maximum capacity of 381 students in year seven of operations.

Strengths:

• The petition presents a plan for growth throughout the life of the initial performance certificate period.

Concerns:

- All research indicates that an attrition rate of 3-7% may not be manageable. The petition states that another school in the network experienced attrition rates of 8.3% (9th grade) and 7.8% (10th grade). While the school may adjust its budget to accommodate a higher attrition rate, the lower end of the attrition rates proposed in the petition may not be realistic.
- The petition states that "there are over 3000 students under 18 years of age in Boundary County, and there are estimated to be over 5000 students in the northern part of Bonner County," according to census.gov (page 106). Schoolage children (5-17) on the same site comprise 2336 students in Boundary County. This may be a more accurate representation of the number of students available for the initial enrollment.
